-All shooting events except Archery require eye protection. Powder burning events require ear muffs. Ear plugs are not acceptable.

- I understand that I must provide adequate EYE and EAR PROTECTION for my child. I also understand that all NRA range and safety rules will be followed.
- I authorize the use of photographs or videos of my child, my family, and myself while attending or participating in the Northwest Invitational Shoot for educational or media purposes.
- I certify that my child is a 2009-2010 4-H member.
- I understand that there must be basic rules for the 4-H Invitational Shoot and these rules must be maintained for the safety of all participants and volunteers. If the instructor deems that my child violates these rules, I understand that he/she may be immediately removed from the competition.
- National 4-H Shoot: Must be age 14 and not have passed age 19 by January 1 of the year of the National Shoot.
