Wisconsin Green Jobs

A team of northwest Wisconsin CRD educators is finishing up a green jobs workforce development training for the Northwest Wisconsin Workforce Investment Board. Beverly Stencel, Tom Wojciechowski, Tim Kane, Pete Kling, Andrew Dane, Gail Huycke organized and presented at two trainings designed to provide workforce development staff in the region with a basic understanding of green jobs and regional implications for the bioenergy sector. In addition, team members are presenting at the May 6-7 Workforce Development conference in Cable, WI. The project included a survey of local bioenergy firms. For more info contact Tim Kane.

Targeting Regional Economic Development

Steven Deller's newest book, Targeting Regional Economic Development, co-edited with Stephan Geotz (Penn State) and Tom Harris (University of Nevada-Reno), was recently published. This volume focuses on revisiting industrial targeting methods in light of the notion of cluster development as advanced by Micheal Porter. Phase II of this project is aimed at providing on-line educational materials along with a selected set of tools aimed at Extension educators and community economic development practitioners.

Grass Roots Survey in Wisconsin

Catherine Willis and Randy Stoecker surveyed 829 grassroots organizations in Wisconsin outside of Dane and Milwaukee counties. They defined a grassroots organization as a membership group that worked on local issues with policy implications. The survey attained a 25% response rate. Their initial findings are that there is vast diversity among these groups. They range in age from only a few years to more than 100 years, and a few members to thousands of members. Some surprising findings are that only about a quarter of the organizations' leaders have participated in leadership education courses, and nearly half have had an organization member run for elected office.

UW-Extension's Hembd receives national distinguished service award

State Specialist Jerry Hembd was recently honored with the 2009 National Distinguished Service Award—the highest honor conferred by the National Association of Community Development Extension Professionals (NACDEP)--at the group's national convention in San Diego. Jerry, who currently serves as Director of the Northern Center for Community Economic Development, was recognized by NACDEP for achievements over the course of his career. Jerry is a faculty member with UW-Superior/Extension.

Jerry's career in community development work began in the early 1980s, when he focused on conducting research, analysis and educational programs related to the role of tourism and natural resources in the northwestern Wisconsin regional economy. He and UW-Extension colleagues were also actively involved in the statewide Community Economic Analysis program. More recently, his research and educational programming have focused on the creative economy of Wisconsin and community sustainability. He helped organize, and currently co-chairs the UW-Extension Sustainability Team, which during the past year offered a statewide in-service on sustainable communities. He was also involved in the development of the Sustainable Communities Capacity Center website (<http://www3.uwsuper.edu/sustainability/index.htm>), and organized a nine-session series of web-based seminars, or webinars, on community sustainability.

Matt Kures to Take on Urban CD Initiative

In response to conversations with UW-Milwaukee and Milwaukee City and County stakeholders, the Center for Community & Economic Development is making a new investment in urban community development. Current CC&ED GIS Specialist Matt Kures will initiate this work with a six-month interim appointment focused on urban community development initiatives. Matt's work will initially feature projects that are being prioritized with the help of UW-Milwaukee Professor and Associate Dean, Sammis White and Milwaukee City Department of Development Deputy Commission Martha Brown. Matt will split his time between Milwaukee and his permanent Madison office. Building on Matt's experience, the CC&ED intends to design a position that will support the broader SE Wisconsin urban corridor and reach out to other Wisconsin urban communities. It is anticipated that this Extension specialist position will ultimately be housed at UW-Milwaukee's School of Continuing Education offices. For more information contact Matt Kures or Greg Wise.

Go Gig Broadband Stimulus Proposal

Andy Lewis has been working with a group from WiscNet and System administration that is developing a proposal for federal broadband stimulus assistance. This proposal has been coined "Go Gig" with more information available on the WiscNet web site at: <http://wire.wiscnet.net/go-gig-broadband-stimulus-information/> One component of the proposal is the establishment of pilot Community Area Networks.
