

Program Overview and Guidelines

Fond du Lac County is offering a special one-day hazardous waste collection program to residents, businesses and farms. Funds for collecting hazardous wastes are provided by grants from the Wisconsin Department of Agriculture, Trade, and Consumer Protection (DATCP).

Residents and farmers may bring their materials to the collection site at no cost. Businesses that generate ag chemicals, or which are VSQG's, are eligible for reduced or subsidized costs.

Household and farm participants are asked to keep individual materials in their separate containers. **DO NOT MIX!** When transporting to the collection site, place materials in a cardboard box. Materials must be brought in containers that can be left at the collection site.

If materials on a farm site are in large containers, please contact the Fond du Lac County UW Extension Office at (920)929-3171 or 929-3173, to arrange to have the materials picked up.

What Can I Bring to the Hazardous Waste Clean Sweep Program?

Residents can bring hazardous wastes to the collection site on November 6, 2009.

Household hazardous wastes are products that are out-of-date or otherwise not being used. They can be found in your basement, garage, under the kitchen sink, craft area, barn, or other places. Look for signal words:

**Caution Warning Flammable
 Danger**
Poison Corrosive Combustible

Acceptable Household Materials

- Solvents (paint thinner, mineral spirits, linseed oil, etc.)
- Pesticides & Herbicides (including DDT & Chlordane)
- Rodent Baits and Poisons
- Lead/Oil Based Paints and Spray Paints
- Varnishes, Shellacs, & Wood Preservatives
- Oven Cleaners, Spot Removers, Polishes
- Aerosols
- Dioxin Materials (such as Silvex & 2,4, 5-T)
- Mercury Devices & Compounds

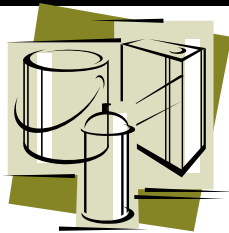


Farmers, rural homeowners, and agricultural small businesses can bring agricultural hazardous wastes to either of the collection site. For large containers, contact UWEX to arrange a pick up.

Acceptable Agricultural Materials

- Unused, damaged, canceled, banned, or otherwise unwanted agricultural chemicals, including herbicides, insecticides, fungicides, rodenticides, & other poisonous repellents & banned chemicals (DDT)
- Veterinary supplies, acid washes, engine cleaners.

UNACCEPTABLE HOUSEHOLD AND AGRICULTURAL MATERIALS

- Latex paint
- Explosives such as ammunition
- Radioactive materials such as smoke detectors
- Waste material
- Compressed gas tanks and high pressure cylinders such as fire extinguishers and propane tanks
- Infectious and biological waste including sharps and needles
- Light bulbs
- Computer components and monitors and TVs
- Appliances
- Freon gases
- Tires



Very Small Quantity Generators (VSQ's) should contact the UWEX office for disposal information.
