

## 2008 BUFFALO COUNTY 4-H FESTIVAL OF ARTS — GUIDELINES

### **PURPOSE of the 4-H Festival of Arts is to provide the opportunity:**

- 1) for 4-H members and Cloverbuds to share their skills and talents with others.
- 2) for 4-H members and Cloverbuds to further develop their skills in communicating through the arts with constructive feedback on their efforts.
- 3) to share with the public the Arts and Communication phases of the Wisconsin 4-H Youth Development program.
- 4) to discover additional arts ideas from others in the area.

### **GENERAL GUIDELINES:**

- 1) Throughout the program, participants and others will not leave or enter the room while a group or individual is performing.
- 2) Please respect the time guidelines in each category.
- 3) Please respect the scheduled performance times. Groups are expected to perform at scheduled times.
- 4) All festival participants must be enrolled Buffalo County 4-H members.
- 5) All participants will receive a ribbon. (***Arts & crafts, photography, and marketing exhibits will receive either a participation or a merit ribbon.***) Merit winners will receive a merit ribbon. Merit awards will be based on quality of the exhibit and age of participant. Only those who follow the guidelines will be eligible for merit awards.
- 6) When selecting material for presentations, please keep in mind that 4-H is a family organization. Presentations should be appropriate for audiences of all ages.
- 7) Each category has a specific set of criteria that will be used by the judges. A summary of the criteria has been included in the description section of each category. For a copy of the complete evaluation rubric for any of the categories, please contact the Extension Office.
- 8) All exhibitors in the Buffalo County Festival of Arts (except Group Musical and Group Drama entries) are eligible to apply to perform at the WI State Fair. If you are interested in being considered for participation at the WI State Fair, please check the box on your entry form. (Group Musical and Group Drama entries will be selected for State Fair at the Area Festival of Arts.)
- 9) The merit award winners in Arts and Crafts (maximum of two per exhibitor) will be taken to the Area Festival of Arts. Decisions for Youth Conference Arts exhibits will be made at the Area Festival of Arts.

## COMMUNICATION ARTS

1) Description -The following categories must have 1 or 2 readers.

- a) **Memorized selection:** Prose, poetry or any other piece, which must be memorized. No notes allowed.
  - Judging criteria: selection is appropriate for exhibitor; exhibitor introduces him/herself; neat appearance/good posture; voice is natural; speaks clearly; uses variety in volume and pitch of voice; maintains rate and pace of speech; poise; originality; eye contact; facial expressions; and shows evidence of practice.
- b) **Prose-reading:** include stories, narratives, anything not written as a poem; should be presented as a reading. No props.
  - Judging criteria: selection is appropriate for exhibitor; exhibitor introduces him/herself; neat appearance/good posture; voice is natural; speaks clearly; uses variety in volume and pitch of voice; maintains rate and pace of speech for selection; poise; originality; eye contact; facial expressions; shows evidence of practice and uses script effectively.
- c) **Poetry-reading:** may be original poem or a selection written by someone else, either in verse form or open-ended; should be presented as a reading. No props.
  - Judging criteria: selection is appropriate for exhibitor; exhibitor introduces him/herself; neat appearance/good posture; voice is natural; speaks clearly; uses variety in volume and pitch of voice; maintains rate and pace of speech; poise; eye contact; facial expressions; performs poetic elements of the selection; maintains poem's rhythm; uses pauses that enhances the delivery; incorporates own emotion; and shows evidence of practice.
- d) **Original speeches:** A speech written by the speaker on any subject, preferably one pertaining to his/her 4-H project work. Notes permitted.
  - Judging criteria: topic is worthwhile and practical; exhibitor introduces him/herself; neat appearance/good posture; grasps interest from the start; states a purpose; main idea is clearly developed and supported with details; well crafted organization of the speech; effective transitions; summary of the speech's main points; welcomes questions and responds accordingly; voice is natural ; poise; originality; shows evidence of practice; speaker is interesting; eye contact; and uses note cards effectively.
- e) **Storytelling:** Original or from a book, told as if to younger children. No poetry allowed. Presented without using notes; costumes or props are encouraged and facial expression and gestures are allowed.
  - Judging criteria: selection is appropriate for exhibitor; exhibitor introduces him/herself; neat appearance/good posture; gets audience's attention; voice is natural; speaks clearly; uses variety in volume and pitch of voice; maintains rate and pace of speech; poise; eye contact; facial expressions; story "comes alive" ; interesting to younger children; shows evidence of practice and uses props effectively.
- f) **Play Reading:** 1 or 2 readers are to make their selection "come alive" without the use of costumes and props. Hand movements and facial expressions acceptable; movement around stage unacceptable. A play reading should be presented as a reading.
  - Judging criteria: selection is appropriate for exhibitor; exhibitor introduces him/herself; neat appearance/good posture; voice is natural; speaks clearly; uses variety in volume and pitch of voice; maintains rate and pace of speech; poise; eye contact; faithful to script and read with accuracy; satisfactory interpretation of lines; establishes a character and maintains it throughout; uses facial expressions; shows evidence of practice and uses script effectively.

2) Time Guidelines - Maximum time for above categories: 5 minutes for all categories.

## SOLO AND DUET MUSIC PERFORMANCES

- 1) Description - may be individual or a team of two
  - a) **Vocal**: (classical, comical, etc.)
  - b) **Novelty**: (lip sync, variety, etc.)
  - c) **Instrumental**: (piano, trumpet, flute, etc.)
  - d) **Dance**: (Irish, tap, jazz, etc.)
  - Judging criteria for **solos**: exhibitor effectively and interestingly incorporates his/her expression into performance; the pitch is pleasant and appropriate for the selection; the sound is desirable and pleasant; the performer exercises clear and clean enunciation; the performer is easily heard and volume is suitable for audience; selection is performed at correct tempo; the pattern and flow of sound is accurate; performer utilizes varied tones and volumes to accentuate the performance; phrases are connected appropriately to the music; selection is suitable for the performer's age and audience; performer is poised and appropriately dressed; and the performance is interesting and holds audience's attention.
  - Judging criteria for **duets**: criteria are the same as above with the addition of the following: both performers are actively involved and exhibit cooperation in performance.
  - Judging criteria for **dance**: performance includes an interesting and varied series of actions; performer effectively incorporates his/her own expression into the performance; appropriate pattern and flow of movement is maintained; movement is carried out with grace and accuracy; uses adequate space on stage; demonstrates conviction and poise; maintains suitable level of energy and enthusiasm; performance is suitable for performer's age and audience; performer is poised and appropriately dressed; and the performance is interesting and holds audience's attention.

## DEMONSTRATIONS, ILLUSTRATED TALKS AND ACTION CENTERS

- 2) Description - may be individual or in teams. **Demonstrations will be judged for premiums at the County Festival of Arts instead of at the Foods Revue.**
  - a) **Demonstrations and Illustrated Talks**: either teach someone how or show and tell how to do something
    1. Consists of 4 parts - a) introduction, b) body, c) conclusion, d) questions from audience
    2. Visuals and charts can be used. Use maps, charts, posters, graphs, pictures, slides or models to explain what you're saying.
    - Judging criteria: exhibitor makes introduction of him/herself and demonstration; neat appearance/good posture; topic is worthwhile and practical; speaks clearly; poise; originality; well prepared; holds audience's attention; shows evidence of practice; coordinates work and speech; equipment is present and suitable; visuals are used; welcomes questions and responds accordingly.
  - b) **Action Center** (informal): a show and tell with an emphasis on showing.
    1. Presenter(s) carry on conversation with passersby (no seated audience)
    2. People watching take part by - a) watching and listening; b) talking with demonstrator; c) trying things with senses; d) judging things; e) asking questions
    3. Handouts may be used (instructions, directions, recipes)
    4. Posters or pictures can be used to show key steps or to show a close-up view.
    - Judging criteria: exhibitor makes introduction of him/herself; neat appearance/good posture; maintains a high level of energy and enthusiasm; project is innovative, interesting & purposeful; speaks clearly; poise; well prepared; holds audience's attention; shows evidence of practice; coordinates work and speech; equipment is present and suitable; welcomes questions and responds accordingly.
- 3) Time Guidelines:
  - a) 15 minute maximum for demonstrations

b) 15-30 minutes for action center

## GROUP MUSIC

- 1) Description -
  - a) Group musicals must have three or more performers.
  - b) Categories include **instrumental, vocal, dance, or novelty** (e.g., variety, lip sync).
  - c) If tapes are used, only instrumental accompaniment tapes are permitted. Vocal tapes will be allowed for lip sync or dance numbers only.
  - d) No **open flames**, hay, straw, cornstalks, shavings or sawdust may be used.
  - Judging criteria: performers interestingly incorporate their own expression; pitch is appropriate and pleasing; sound is pleasant; enunciation is clear and clean; performers are easily heard and volume is suitable; tempo is correct; rhythm is accurate; selection is suitable for performers; performers maintain a comfortable manner and are dressed appropriately; performance is interesting; group displays enthusiasm; and teamwork is evident.
- 2) Time Guidelines - The maximum performance time limit is 12 minutes. Clock starts with opening of curtain. No minimum time limit.
- 3) ***No directing is permitted from the audience or in front of the stage.***

## GROUP DRAMA

- 1) Description –
  - a) Group dramas must have three or more performers.
  - b) One Act Play, commercial or original drama.
  - c) No **open flames**, hay, straw, cornstalks, shavings or sawdust are to be used.
  - Judging criteria: selection is appropriate for group; performers are easily heard; uses variety in volume and pitch of voice; maintains rate and pace of speech; poised; eye contact, satisfactory interpretation of lines; establishes characters and maintains throughout; facial expressions; well practiced; appropriate use of props and stage sets; appropriate costumes; excellent stage presence; evidence of teamwork; all members actively involved and expressing enthusiasm.
- 2) Time Guidelines - The maximum performance time limit is **30 minutes**: opening curtain to final curtain. No minimum time limit.
- 3) ***No directing is permitted from the audience or in front of the stage.***

## GROUP MINI-DRAMA

- 1) Description – Group mini-dramas must have three or more performers. Produced with **minimal** props (no special lighting, hay, straw, candles or open flames) and costumes, they may be performed in a classroom. Examples include skits, puppetry or creative dramatics.
  - Judging criteria: selection is appropriate for group; performers are easily heard; uses variety in volume and pitch of voice; maintains rate and pace of speech; poised; eye contact, satisfactory interpretation of lines; establishes characters and maintains throughout; facial expressions; well practiced; appropriate use of props and stage sets; appropriate costumes; excellent stage presence; evidence of teamwork; all members actively involved and expressing enthusiasm.
- 2) Time Guidelines - A maximum time limit of 15 minutes, including set-up and take-down. No minimum time limit.

## GROUP PLAY READING

- 1) Description -
  - a) Group must consist of 3 or more participants
  - b) Readers are to make their selection "come alive" without the use of costumes and props.
  - c) Hand movements and facial expressions are acceptable. Movement around the stage is not acceptable.
  - d) Presented without microphones or artificial devices.
  - e) Scripts are to be used.
  - f) Play readings will be performed in a classroom.
  - Judging criteria: selection is appropriate for group; performers are easily heard; uses variety in volume and pitch of voice; maintains rate and pace of speech; poised; eye contact, satisfactory interpretation of lines; establishes characters and maintains throughout; facial expressions; well practiced; excellent stage presence; evidence of teamwork; all members actively involved and expressing enthusiasm.
- 2) Time Guidelines – Maximum time limit is 12 minutes

**Please note: Art & Crafts, Photography, and Marketing items do not have to be pre-entered. Please attach an entry tag securely to the front of the exhibit in an area that is easily read but does not distract or cover the exhibit.**

*Reasonable care will be given when handling and transporting Art, Craft, Photography and Marketing exhibits. However, please note that exhibits are entered at your own risk. Significant handling of exhibits occurs during judging and transport of items. UWEX staff, 4-H volunteers and Festival judges will not be held responsible for damage to exhibits.*

## PHOTOGRAPHY

- 1) Entry Labeling – All photographs must have an official entry tag attached to each exhibit that will include the following: **name, club, grade, month/year photo taken, photo title, and a brief description of the photo (use the form provided)**. Attach cards securely on the front of the exhibit in such a way that it is easily read and minimizes distracting from or covering the photo.
- 2) Description - All photo entries will be displayed together on a display board. Photos submitted must be 5" x 7" photos. *Photos may be color or black & white, standard or digital, or any appropriate subject.* Categories are limited to animals, people, and scenes. *Photos must be mounted on top of poster board (any color) measuring 6"x8".* **Only current work done by the 4-H member will be allowed. Last summer's County Fair exhibits are eligible for exhibit at this Festival, however articles shown at any prior year Festival of Arts are not eligible.**
  - Judging criteria: lighting is appropriate for the subject; exhibit reflects appropriate composition techniques; photo is unique and holds interest of intended audience; photo is clear, sharp and lacks obvious mistakes; photo has a main center of interest and is suitably displayed in the frame; photo communicates a clear and purposeful viewpoint or message.
- 3) Time Guidelines - All articles will be judged during the Festival. Exhibits will be released when judging is complete. Photos receiving Merit Awards should be left so they can be judged and displayed at the Area Festival of Arts. All other photos must be taken home.
- 4) Exhibit Limit - **Each exhibitor is limited to 10 entries. Only two pieces per exhibitor are eligible for**

**a Merit Award.**

## MARKETING

- 1) Entry Labeling – All Marketing items must have an official entry tag attached to each exhibit that will include the following: **name, club, grade, month/year exhibit completed, and a brief description of materials used and how the marketing item will be used (use the form in this newsletter)**. Attach cards securely *on the front of the exhibit in such a way that it is easily read and minimizes distracting from or covering the appearance of the article.*
- 2) Description - All items submitted will be displayed together. Any item is acceptable that can be used for promotion of 4-H. All entries must have at least one green clover with the four H's. Examples would include posters, placemats, tabletop design, sweatshirts, etc. that promote 4-H visually.
  - Judging criteria: exhibit reflects the promotion of 4-H in an interesting manner; is innovative and original; is neat and professional in appearance; contains accurate and positive 4-H information; successfully conveys a promotional 4-H message; and exhibit is appropriate for intended audience.
- 3) Time Guidelines - All articles will be judged during the Festival. Exhibits will be released when judging is complete. Exhibits receiving Merit Awards should be left so they can be judged and displayed at the Area Festival of Arts. All other exhibits must be taken home.

## ARTS & CRAFTS

- 1) Entry Labeling – All Art & Craft items must have an official entry tag attached to each exhibit that will include the following: **name, club, grade, month/year exhibit completed, title, and a brief description of medium/materials used and work done to make the exhibit (use the form provided)**. Attach cards securely on the front of the exhibit in such a way that it is easily read and minimizes distracting from or covering the appearance of the article.
- 2) Description – All arts & crafts entries will be displayed by grade only. ***Only current work done by the 4-H member will be allowed. Last summer's County Fair exhibits are eligible for exhibit at this Festival, however articles shown at any prior year Festival of Arts are not eligible.***
  - a. Art is considered any item of original design.
  - b. Craft is considered any item made from a kit or from specific instructions/guidelines.
- 3) Time Guidelines - All articles will be judged during the Festival. Exhibits will be released when judging is complete. Items receiving Merit Awards should be left so that they may be displayed at the Area Festival of Arts. All other items must be taken home.
- 4) Exhibit Evaluation -
  - **Art** judging criteria: exhibit is innovative and original; illustrates the exhibitor's unique creativity; exhibit demonstrates workmanship and skill; exhibit is aesthetically pleasing; skill needed is challenging, yet suitable for age; appropriate finishing perfects the exhibit.
  - **Craft** judging criteria: exhibit reflects the craft was completed according to basic directions; exhibitor has incorporated his/her own unique creativity into exhibit; the exhibit is neat & clean; exhibit demonstrates workmanship and skill; exhibit is aesthetically pleasing; skill needed is challenging, yet suitable for age; appropriate finishing perfects the exhibit.
- 5) Exhibit Limit - ***Each exhibitor is limited to 10 entries. Only two pieces per exhibitor are eligible for a Merit Award.***
