RE: 2008 Market Animal Educational Meetings and Rule Changes  
DATE: January 21, 2008

Please find a list of market animal educational meetings that are being offered this year. You will notice that poultry and rabbit meetings are included for the first time. The rules concerning meeting attendance are as follows:

1. Youth are expected to attend at least three educational meetings throughout the year.
2. At least two of the meetings must be from the enclosed list of "county-offered" meetings. Attendance at an educational event sponsored for youth such as FFA events, show camps, showing at district and state shows, etc., qualify to replace a "county-sponsored" event (attending a county market animal sale will not qualify as an educational meeting).
3. Youth may not count more than one meeting that does not relate to the species they are exhibiting at the fair.
4. It is the member's responsibility to provide proof of participation to the **Market Animal Sale Committee** (prior to weigh-in) for any event that is not county sponsored.
5. Youth who do not attend at least two meetings will not be allowed to sell an animal in the Market Animal Sale at the fair.

### **NEW RULES and CHANGES – 2008**

1. Market steers must be "halter broke" at weigh-in on April 5 (not just wearing a halter!).
2. Broilers: weight has been changed from 2.5 to 4.5 pounds to 2.5 to 5.0 pounds.
3. Market Poultry and Market Rabbits will be weighed in at the fair prior to judging.
