The undersigned certifies that, to the best of his/her knowledge, as of the date of shipment or delivery, none of the livestock shipped to or delivered to the market resale or locker plant will be, on such date adulterated within the meaning of the Federal Food, Drug and Cosmetic Act (i.e., none of the animals will have been fed any feed containing protein derived from mammalian tissues, e.g. meat and bone meal, as that term is defined in 21 CFR 589.2000 and none of the livestock will have an illegal level of drug residues).

All Auction Consigners:

We have read and discussed the General Fair and Auction rules in the Green County Fair Book and agree to follow them, with the understanding that failure to do so will result in relinquishing our right to sell animals in the auction. We acknowledge that selling in the auction is a privilege that must be earned by meeting all the criteria specified in the auction rules.

I hereby certify that all of my auction animals will enter the food chain free of drug residues or foreign substances and that any drugs that have been administered to my animals have been administered in accordance with applicable federal and state laws. I also certify that all my auction animals are of United State of America origin.

As a condition for participation in the Green County Fair Meat Animal Auctions I agree to submit my animals for inspection by a veterinarian appointed by the Green County Fair Association and to have my animals submitted to any tests that may be designated by the veterinarian or buyer.

Also, I hereby agree to sell animals only in the Green County Meat Animal Sale. I will not sell at any other County Junior Fair Auction. If in violation of this rule, I understand I will forfeit all eligibility to participate in future Green County Fair Meat Animal Auctions.
