



GUIDELINES FOR BEHAVIOR

This form applies to any delegate representing Sheboygan County under the supervision of the Sheboygan County 4-H Leaders. The delegate and his/her parent/guardian must sign this form for the delegate to be eligible to participate in the activity.

agree to the following guidelines as approved by the Sheboygan County 4-H Leader's Association.

All delegates participating in youth activities shall be responsible for their own actions and must abide by rules set up for that activity even though they are of legal age.

RULES:

1. There shall be no defacing of public property. Any damages to any property or furnishing in the hotel rooms or buildings must be paid by the individual(s) or club responsible.
2. Delegates shall keep their adult advisors informed of their activities and whereabouts at all times.
3. Delegates should be prompt and prepared for all activities.
4. Delegates should be financially prepared for all possibilities.
5. Delegates shall stay in designated housing, not with friends or relatives.
6. No alcoholic beverages, tobacco product of any kind, or narcotics in any form shall be possessed by delegates at any time, under any circumstances.
7. No delegate shall leave the grounds unless they are accompanied by their advisor. Delegates shall not use their own cars or ride in cars belonging to others unless accompanied by an adult advisor.
8. Delegates are required to attend all general sessions and activities assigned, committee meetings, etc., for which they are registered unless engaged in some specific assignment taking place at the same time.
9. Identification badges, if provided, will be worn at all times.
10. Appropriate dress will be expected.
11. Curfew will be enforced. (Curfew means delegates will be in assigned rooms.)

Failure to abide by the provisions of this agreement will result in one or more of the following consequences. Penalties will vary with the severity of the infraction.

CONSEQUENCES

1. May be sent home immediately at the parent's/guardian's expense.
2. No refund of any money for the event.
3. May be denied privilege of showing at County Fair.
4. May be denied privilege of showing in any State qualifying show.
5. May be denied privilege of showing at State Fair.
6. May be denied privilege of applying or being nominated for any 4-H awards.
7. A permanent record may be placed on file with the County 4-H Executive Board, County Extension Office, and made available to other county offices or District Councils.
