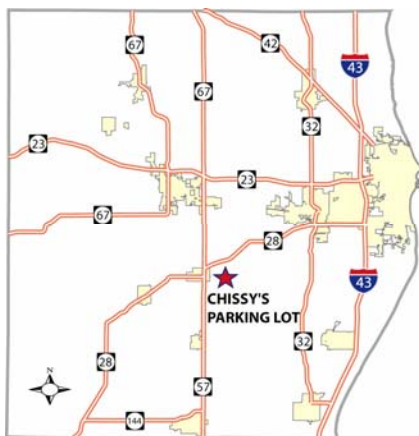

### **Conditions of Sale**

1. All hay must be at auction site no later than 10:30 a.m. on date of sale. Arrival after 10:30 a.m. will not guarantee that the hay lot will be listed on the sale order and will be placed on the sale order at the discretion of supervising Forage Council member.
2. Hay will be offered for sale in order of arrival at market site on sale date.
3. Terms of sale: Cash or Approved Checked.
4. Sales commence at 1:00 p.m. sharp subject to local conditions.
5. Hay will be sold by NIR Test.
6. Forage Council personnel are responsible for sample procurement.
7. Hay will be sold on weight basis unless otherwise determined.
8. All hay lots must be loaded to be easily accessible for core sampling. The auctions reserve the right to reject loads improperly loaded or the lot will be sold subject to buyer approval.
9. Cosigner is responsible for quality and conditions of hay. Any cosigner found to be deliberately misrepresenting or altering their product shall be barred from further participation in the sales.
10. All sales F.O.B. auction site unless other arrangements are made.
11. Sellers must assist buyers to reload hay at market site.
12. Buyers will be asked to verify credit.
13. A bill of sale or disclaimer is required.
14. Minimum sale lot will be 40 regular sized squares.
15. Commission rate of 6% or minimum of \$5.00 per load for both hay and straw and \$15.00 testing fee per lot payable to sale agency.
